Access	Is ODE connected to KReady?	Yes, but ODE cannot login to see student scores. Only local data managers and teachers have that access. The Help Desk can see in KReady at a level that gives them access to data at the organization so that they can provide technical assistance. ODE will receive reports from KReady through our partners at Johns Hopkins University who host the KReady system.
Assessment Administration	Currently we have teacher do the paper form of ELA and then we have one person who enters it electronically. Can a Data manager have a teacher role as well and be able to enter ELA data?	This would be a local decision regarding how to facilitate enrollments. The data manager could assign student enrollment to the assessment to their teacher account.
Assessment Administration	We are not a district, what is a state student ID?	If you are an ECE grantee, your students will be assigned a state student ID (SSID) after you submit their applications. Assessment Policy	If we are going to do the pilot program, do we need to wait to hear that we are accepted before moving forward with uploading for the fall data collection? I see that there is a different token.	Your program/district can choose whether you will participate in the pilot. There is no approval or acceptance process. If you have completed the form to indicate that you plan to participate in the pilot, you may proceed with enrolling students and teachers into the pilot data collection.
Data Loading	The district of residence has been responsible for reporting student results to EMIS, but in many cases, the students are attending at the ESC or other district. The ESC or other district conducts the training. The district of residence would not have access to the student results and would manually load to their SIS How will this be handled now?	Districts will not report ELA scores in EMIS this school year. The data manager of the program can share student results with the district, or the district can enroll the student in their KReady organization so that they can also have access to the results in KReady.

If the students are entered into KReady with their correct SSID, they can be associated in KReady with either the district of residence or the school where they are served.
Data Loading	So, there are 3 templates that must be completed?	There are three templates that are used to enter data into the KReady System through the Bulk Loader. Those are the Teachers, Students, and Enrollments templates.

Reporting	We have the county DD students and some of our entered the ECE Grant as well. Second question is that these ELA scores are sent to the state via the K-Ready system, correct?	Yes, the Ohio Department of Education will receive the scores directly from the KReady system this year. If the students are entered with their correct SSID, we will be able to match them to their resident district or the ECE grant
Reporting	How will KReady report these scores to ODE? Do we simply enter scores in KReady, and we are done?	Yes, ensure that teachers enter the ratings in KReady. ODE will receive a secure file from our partners who host the system.
Reporting	IF a student is an ECE student at our district-home district- and on an IEP at the ESC who is the point of authority for the ELA and who reports the student?	Either program can enter the assessment scores into KReady. Because there is no reporting into EMIS or EAS this year, the scores can be matched to the correct program if the student demographic information is entered correctly particularly SSID.
Reporting	How will we know if students are reporting from our district and do not have scores entered? We used to get this report of missing scores via EMIS	We are going to run a missing students report during the window for students who are required to be assessed. It will only tell you if a student has not been entered into a data collection. You will want to run an SKB report to verify scores have been entered.
Reporting	When we enter children in the EAS will it transfer to KReady, or we need to enter children?	The EAS and KReady are two separate data systems. One does not input to the other. Teacher, student, and enrollment data will need to be loaded to the KReady system either manually or using the Bulk Loader.
